



Fruit Fly Entrust® Self Baiting Terms and Conditions

These terms and conditions apply to properties within a Riverland fruit fly outbreak Area under the Plant Health Act 2009 (the Act).

As you may be aware, the Minister for Primary Industries and Regional Development (the Minister) has declared by notice dated 26 April 2022 (published in the Government Gazette dated 5 May 2022 at pages 1052-1056), certain measures for the treatment of fruit fly in a fruit fly outbreak area.

For properties in an outbreak area, those measures can include 4 weekly applications of Entrust mixed with Sulphur applications on grapevines. In the context of the current eradication program:

- PIRSA will apply fruit fly bait within a 200m buffer around the confirmed outbreak trigger site
- Growers with commercial properties inside the declared 1.5 km outbreak area but outside the 200m buffer around a trigger site are able to apply Entrust to assist in the eradication of fruit fly. Once the Entrust which has been provided under this agreement has been used you may apply for more.

Once registered, commercial growers can collect Entrust from PIRSA. PIRSA staff will then determine the quantity of Entrust you will receive based on the area (ha) of your property that requires baiting. Collection is available by appointment only. The following insecticide will be supplied for use to meet the requirements on your property:

- Entrust® - mix with Sulphur at the label application rate for Light Brown Apple moth of 20ml/100L (Entrust® is legal to use in grapevines and stone fruit under SA legislation despite the label not listing fruit fly as a target pest)

IMPORTANT: Where grapes are being grown for winegrape production, an export harvest interval of 'Use no later than E-L 31, berries peasize (not > 7 mm diameter)' applies. Consult your winery or grape purchaser prior to considering applications beyond this growth stage.



It is recommended to -

- Apply as a tank-mix with sulphur or other fungicides however, there is little information on incompatibility issues so performing a basic 'jar test' prior to spraying is suggested. To do this -
 - mix up a jar at the same rate as the chemicals being applied and leave to stand until the solution settles,
 - during this time monitor the jar to determine if any of the chemicals drop out of solution,
 - if no chemicals drop out of solution, then further test the solution by applying some of the mix to foliage and fruit to see if damage occurs over the next 24hrs.
- To break the life cycle of fruit fly, apply once every 4 weeks, to a maximum of 4 applications per season
- Commence application after fruit set to avoid impacts on bees and other pollinating insects
- Re-apply if washed off by rain
- Refer to Product Label and SDS for specific application information
- Record applications in your standard spray diary

The insecticide is provided on the following terms and conditions:

- you must provide a property map, including an accurate calculation of the area (in hectares) which will be sprayed by you
- you must only use fruit fly insecticide products provided to you by the Minister as directed.
- it is desirable that you provide evidence of Chemical training when you collect any insecticide.
- you must return to the Department of Primary Industries and Regions any unused fruit fly insecticide provided to you by the Minister, unless otherwise authorised in writing.
- there are two ways to provide the map. Either bring your property map with you when you collect the Entrust or work with PIRSA staff to identify the areas you will be spraying
- by agreeing to participate, you agree that your property details will be shared with the relevant industry for the purpose of identifying areas that are not being baited.

Please note:

The self-baiting program has separate requirements which are in addition to any market access requirements, including:



- The self-baiting program does not relate to any market access accreditation for the treatment and movement of fruit.
- If you are in both a market access program and the self-baiting program, you are required to meet the requirements for both.
