



Fruit Fly Attract and Kill Device (AKD) Distribution Terms and Conditions

These terms and conditions apply to properties within a Riverland fruit fly outbreak area under the Plant Health Act 2009 (the Act).

As you may be aware, the Minister for Primary Industries and Regional Development (the Minister) has declared by notice dated 26 April 2022 (published in the Government Gazette dated 5 May 2022 at pages 1052-1056), certain measures for the treatment of fruit fly in a fruit fly outbreak area.

For properties in an outbreak or suspension area, those measures include the use of PIRSA approved attract and kill devices which growers are able to collect and deploy on their property. In the context of the current eradication program:

- PIRSA will use attract and kill devices (AKDs) within a 200m buffer around the confirmed outbreak trigger site.
- Growers with properties inside the declared 1.5 km outbreak area and inside the 15km suspension area, but outside the 200m buffer around outbreak trigger site, can deploy AKDs on their property. By deploying these devices, you agree to supplying PIRSA with information regarding their location. You also agree to retrieve these devices if they are not biodegradable and return to PIRSA.

You must register to receive the AKDs which will be available from PIRSA staff who will determine the number of devices you will receive. Collection is available by appointment only. Please phone the fruit fly hotline on 1300 666 010 to book in a time.

The AKDs supplied to growers to meet these requirements are called MAT cups.

The AKDs are provided to you with the following terms and conditions:

- if possible, provide a property map, including an accurate calculation of the area (in hectares) over which the AKDs will be deployed.
- you must only use fruit fly AKDs provided to you by the Minister as directed.
- you must return to the Department of Primary Industries and Regions any unused fruit fly AKDs provided to you by the Minister, unless otherwise authorised in writing.
- you must maintain a record detailing the GPS location of all fruit fly AKDs provided to you by the Minister as well as their appropriate QR code. This can be done either by –
 - ✓ using the QR link given to you once you have collected the AKDs.
The QR code links to an online form that can be used on your phone



- or iPad to scan the QR code attached to the AKD and upload the GPS co-ordinates.
- ✓ providing a map at the time of collection detailing where the AKDs will be located
 - ✓ hard copy using the template below. Hard copy AKD locations must be delivered during opening hours to the Loxton Research Centre, 1801 Bookpurnong Road, Loxton.
- if needed PIRSA can send someone out to your property to work with you and record this information.
 - you must monitor the AKDs monthly.
 - you are strongly encouraged to retrieve and replace AKDs every 3 months. If this occurs, you must notify PIRSA either by
 - ✓ using any system provided to you by PIRSA or
 - ✓ via email to the fruit fly email at fruitfly@sa.gov.au or
 - ✓ by phoning the fruit fly hotline on 1300 666 010 and providing your name, business name, phone number and the number or barcode numbers of the AKDs collected.
 - Once collected you must dispose of any used containers safely. This can be either by –
 - ✓ placing them in your general waste bin or
 - ✓ crushing and burying away from water sources or
 - ✓ returning to PIRSA for disposal
 - you must collect all of the non-biodegradable AKDs provided by PIRSA and deliver to PIRSA staff for sign off at the Loxton Research Centre, 1801 Bookpurnong Road, Loxton or by other method or location as directed. This will stop any interference with the monitoring grid.
 - by agreeing to participate, you agree that your property details will be shared with the relevant industry for the purpose of identifying areas that are not being baited.
